WHAT IS THE E.M.A.J.?

THE E.M.A.J. is an organization for co-operation between all evangelical missionaries in Japan, standing unreservedly for fellowship in the Spirit, and correspondingly the abstinence from every appearance of evil.

THE E.M.A.J., although in hearty sympathy with other organizations for evangelical co-operation, is not officially linked with any of them, either in America or Japan, and is in no way committed to policies set by other inter-mission organizations.

THE E.M.A.J. is seeking to maintain a united testimony among evangelical missionaries in Japan, but at the same time recognizes the distinctive doctrines and policies of the various groups. It is not the purpose of the Association to interfere with the activities of any co-operating Mission. The one requirement for membership in the E.M.A.J. is a whole-hearted agreement with the organization's strongly evangelical Statement of Faith.

THE E.M.A.J., through deeper life conferences and regular fellowship gatherings, strives to encourage Scriptural and spiritual fellowship among evangelical missionaries.

THE E.M.A.J., through publications and other means, purposes to gather and disseminate information that will be helpful and inspiring to all evangelical missionaries.

SIXTY-SIX SOCIETIES

According to the latest figures available, there are now sixty-six evangelical societies working in Japan. May the Holy Spirit bind us all together in holy, aggressive love-for His glory and the salvation of lost souls.

THE INCOME TAX PROBLEM

OUR CONSTITUTION

Preamble

WHEREAS, it is the express purpose of our Heavenly Father, to call out of the world a saved people who shall constitute the body or church of our Lord Jesus Christ, built and established upon the foundation of the apostles and prophets, Jesus Christ Himself being the chief corner stone; and

WHEREAS, the members of the body, the church (ecclesia) of Jesus Christ, are so enjoined to assemble themselves together for worship, fellowship, council, and instruction in the Word of God and the work of the ministry, therefore be it

RESOLVED that we recognize ourselves a co-operative missionary body of evangelicals in Japan.

Name

The name of the Association shall be "The Evangelical Missions Association of Japan."

Purpose

This association shall be established as a non-profit, religious, educational and charitable corporative fellowship devoted to the propogation of the Christian faith and to provide a means of unified action and co-operation under the guidance of the Holy Scriptures in any of the following activities:

- 1. (a) Promotion of Christian fellowship; (b) Promotion of field comity; (c) Provision of field information; (d) Any other activity which may be adopted by this association not in conflict with the laws governing voluntary religious and educational corporations.
 - 2. Representation before government, when necessary.

Statement of Faith

- 1. We believe the Bible, as originally given, to be the verbally inspired, the only infallible, authoritative Word of God. (II Tim. 3:16, II Peter 1:21).
- 2. We believe there is one God, eternally existent in three Persons, Father, Son, and Holy Spirit. (Deut. 6:4, Isa. 43:10, 11, I Tim. 2:5, I Cor. 8:4, Matt. 28:19).
- 3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory. (John 1:1, John 1:18, Heb. 1:8, I Cor. 15:3, 4, I John 5:20, Tit. 2:13).

- 4. We believe that all men are sinners and that for the salvation of lost and sinful man, regeneration by the Holy Spirit is absolutely essential. (Rom. 3:23, John 3:7, Luke 24:46, 47, Rom. 10:9, 10, John 1:12, 13, 1 Pet. 1:18, 19, 23).
- 5. We believe in the present ministry of the Holy Spirit, by whose indwelling the Christian is enabled to live a godly life. (Tit. 3:5, Gal. 5:22, 23, I Thess. 5:23, 24).
- 6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation. (John 5:23, 29, Rev. 14:11, Rev. 20:11-15).
- 7. We believe in the spiritual unity of believers of our Lord Jesus Christ. (Rom. 12:5, I Cor. 10:17, Gal. 3:28, John 17:21, Eph. 4:13).

Membership

Membership in this association shall consist of individuals who subscribe to the constitution and who have paid the membership fee or annual dues as prescribed in the by-laws.

Missionary societies and organizations who desire to become members as such may be admitted upon favourable action by the Executive Committee as determined in the by-laws. Prospective members and member societies may apply to the association in session, or to the Executive Committee as provided in the by-laws.

(Other sections of the constitution and by-laws, dealing with officers, committees, voting, etc., have been omitted because of lack of space).

The following revision in the annual dues is under consideration:

When joining as an individual, ¥ 500 per year.

When joining as a group, ¥ 400 per year (per person).
